c) Information Received From Third Parties

We may receive your data from:

Property portals (Rightmove, Zoopla, OTM), joint agents, solicitors, mortgage brokers, surveyors, EPC assessors, contractors, CRM systems, and other service partners.

d) Property Transaction Information

This includes appraisal notes, viewing info, feedback, negotiation details, offers, and sales progression updates.
